Dear WNDA Member or Interested Bowler,

Our third event of the season is about to get underway at Glen Burnie, MD, marking the halfway point in our season.

We have been busy preparing for our next event to be held in Johnston, RI, at Town Hall Lanes over the August 6-8 weekend. We have received a fair amount of advance interest in the event, which will be held concurrently with the DPBA. We will have 12 lanes per shift and, since we believe in making every reasonable effort to accommodate as many bowlers as possible, we have **scheduled three shifts on Saturday at 8:30, 1:30, and 6:30**. This lets us take up to 72 bowlers. If there is a need to do so, we can add a Friday evening shift to allow more bowlers to participate. However, adding a Friday shift will only be done if we have 10 or more members requesting that time slot.

At Town Hall, the scoring system requires configuration and bowler information in advance. As a result, we will assign bowlers to lanes based on the postmark and receipt of their entry form. To allow time to process all of this additional information and setup, **the due date for entries is July 26**. Please get your entries in as quickly as possible and postmarked before this date to avoid a late fee.

As a reminder, anyone desiring to qualify for an invitation to the Grand Prix Invitational needs to bowl at least one event in the New England area (CT or RI) and one in the Maryland/DC/Virginia area. If you did not bowl in Connecticut, this is your final opportunity to meet the New England requirement.

Due to recent experiences by DPBA members at a hotel in the Warwick area, the ownership has offered a steeply discounted rate of \$70 per night at one of their other properties, the Sheraton Providence Airport. It is located at 1850 Post Road, Warwick, RI 02886. Call them direct at (401) 738-4000 and be sure to identify yourself as being with the DPBA/WNDA Duckpin Pro Tour group. Check the WNDA website or earlier e-mail messages for other lodging discounts.

This event is the deadline for everyone to turn in raffle tickets and monies. Vicki Kramer will be present to collect them from you. **PLEASE DO NOT BRING CASH**; make any checks payable to WNDA. Proceeds from the ticket sales are important to operation of the WNDA.
