No bowler will be permitted to bowl without a completed WNDA Membership Application, whereby averages can be verified prior to the tour stop. New members must complete the Membership Application and enclose it with your tour entry form. Shift assignments will be made on a first-come, first-serve basis using the <u>paid</u> entry's postmark. Bowlers must check in at least 30 minutes prior to their shift time.

As noted in the member letter, fifty (50) \$1.00 raffle tickets <u>must be paid for prior to participating in a member's first event</u>. Members may choose to buy the tickets themselves or sell the tickets, but, in no event, can participate until the raffle tickets have been paid for.
